If you choose to use our Service, then you agree to the collection and use of information in relation with this policy. The Personal Information that we collect are used for providing and improving the Service. We will not use or share your information with anyone except as described in this Privacy Policy.

Payments and Delivery

All Padel Solutions UK LTD services must be paid in full at the time of order. Your membership at Stratford Padel Club is effective as soon as the payment is received. Renewal of membership is not automatic.

Bookings for matches and courts require payment by card or using a pre-paid voucher and are effective as soon as the payment is received. At the point of payment, you have the opportunity to check date and time of booking. For all bookings, you will receive a confirmation email. Non member packages of up to 6 matches need to be used within 3 months from the date of purchase. Non member packages of more than 6 matches need to be used within 6 months from the time of purchase.

Stratford Padel Club accepts credit and debit card payments without capturing or storing card information. Payment information is collected by our secure payment providers. **We do not store credit card details nor do we share financial details with any 3rd parties.**

Refunds and Cancellations

For court bookings, "I'm in" matches and tournaments, cancellations are allowed if made at least 24h before the event and a full refund will be processed in up 7 days. Cancellations made 24h or less prior to the event booked will incur payment in full. Annual memberships can be frozen for up to 2 months, if player is injured and cannot play during this time. Information Collection and Use
